The members suggested the following:

1. Academic Budget:

The Governing Council has approved the proposed budget for the academic year 2012-13. Suggestions were given to include the department faculty salary in the Academic Budget and also to prepare the budget based on the previous year's obligation. Contingent for the own obligation of the budget should also be included by incorporating the suggestions to the Management.

2. NSSC achievements

The students and staff achievement in NSSC online certifications were appreciated by the Governing Council Members. It was suggested to categorise the statistics of NSSC.

encouraged equality for faculty and students and also to encourage the students with attractive conditions.

3. Placement and Training

The members highlighted the placement activities in engineering disciplines. Dr. Jyoti Datta, the chair of IT, placed an emphasis upon all the departments. It was understood that the IT commitment was spread to guide candidates from the departments of CE and EI. They also stated that appropriate training may be given to the recruited students before the recruitment drive from the IITs, awards and incentives through "Join the Trainee" programmes. The member Secretary explained in detail about the technical and soft skills as mentioned below.

The training activities for the best and talented students towards placement in their dream companies like Google and Microsoft etc. were projected.

The members were interested in understanding the details of internship and suggested that the students should also be sent to

It was suggested that some industries may be invited as their to prepare the cost analysis of student during their laboratory and also to establish a bank of funds

It was also suggested that computer specific training may be given to students based on industry needs.

Research and Publications.

The governing council members have appreciated the efforts to obtain the funds from IIT but expect more to be extended to other organizations to obtain funds. In the regard it was suggested that target for publications in IIT/Journal should be set for the faculty to secure the improvement in the knowledge of the college.

An exclusive committee should be constituted to assess and improve the relations of the published papers. Dr. N. Maheshwari accepted to accept the invitation on this regard. He also advised the departments to submit proposals to organizations like CSIR, IITM under CSR category, IITM, joint proposals

in IIT under Birds Topan and other
colleges etc. to increase the standard of
research.

Patents:

More number of patents should be applied
and published to improve the IIT status of
the colleges which is mandatory for ARA
and autonomous status.

2. Cells with Industries

The governing Council Members appreciate
the existing IITs suggestions were made to
connect with MOEs with foreign Universities
to enable knowledge sharing on par with
global standards and for updation in new
research trends.

2. Projects and clubs Open House Project Expo

An Open House Project Expo should be
organised by all the effective Technical Clubs
to expose the talents to the industry expert
and also widen the visibility of the club
to the external participants from various
Other colleges. Students should be encouraged
to participate in National level Project
competitions held at IIT, IIS, etc.

Decide for projects would be reviewed with the inspection of the authorities supported by IIT Bombay where details would be given by Dr. P. B. Hattis.

It was suggested that the follow up of the meeting should be discussed in the next Governing Council Meeting.

5. Autonomous Status

The process towards application of autonomous status was projected during which the members reported the working towards the process with an intention the members volunteered to assist the college in identifying appropriate members for the constitution of various committees like I.T. Board, Council etc.

6. Entrepreneurship Development Cell

The members appreciated the efforts of the I.T. but also reported there to be a need in providing entrepreneurial cell and also to display the finer details comprising of the percentage of students as entrepreneurs with the names of their companies.

The Member recommended the change in pedagogy through flipped classrooms, student involvement in lectures part etc.

11. Adoption of colleges:

The Member advised that the neighboring colleges could be adopted to improve the availability of the college at its vicinity.

12. Career Guidance Programme:

The Member suggested that students should be encouraged to pursue GAT and JEE exams for the higher studies abroad.

13. The Principal requested the guidance of Dr. P.V. Narasimhan, Professor to analyse the provided curriculum of Regulation 2017 to understand the requirements and methods to bridge the knowledge gap.

14. Dr. P.K. Murthy appreciated the efforts of the Department of Biotechnology in honing the unique skills of their students and encouraged the Humanities and Social Science Department to contribute towards skill development programmes.

If Dr. A. Hanuman suggested that cost
initiative through digital library may be
explored to enhance the learning
process.
