- √ 8. Required number of Technical, Ministerial and other supporting staff should be appointed.
  - 9. Academic performance of the students needs to be improved.
- ✓ 10. Common facilities for Physical Education should be made available as prescribed.
  - 11. Adequate Hostel facilities should be made available.
  - 12. Financial stability should be improved.

- 13. Safety certificates obtained from different agencies should be produced.
  - 14. Necessary land documents should be produced.
- ✓ 15. The college should satisfy all the affiliation conditions enclosed and any other conditions as and when stipulated by the University.
- ✓ 16. An inspection committee will visit your college to verify the compliance submitted, in January-February, 2004 and the college should comply with conditions, if any, stipulated by the University for affiliation. In the case of revalidated AICTE approval obtained additional course(s) / variation in intake in the existing course(s) for the academic year 2003-04, an inspection committee will inspect your college in due course and the college should comply with conditions, if any, stipulated by the University for affiliation.
- √ 17. A duly signed undertaking by the management to satisfy all the above requirements on a Rs.10/- non-judicial stamp paper should be submitted on or before 15-07-2003 and a compliance report should be submitted meeting the above requirements on or before 31-10-2003.
- 18. If the management fails to rectify the above marked deficiencies, either the sanctioned strength of the courses will be reduced or the affiliation granted will be withdrawn, for the academic year 2004-05.
- √ 19. The Provisional affiliation / continuation of provisional affiliation pre-supposes the approval of the AICTE for the courses concerned.
